
## **Expansion of the Service Sector**

Two main questions:


- Does the assertion of the "gap in service sector" between the USA and European countries like Germany or Switzerland still hold true?
- Is there any evidence for an increase in earnings inequality due to a polarization into low-paying and high-paying service jobs in the 1990s?






